Chair Carter called the meeting to order at 7:00 PM. All in attendance rose and said the pledge of allegiance.

Supervisor Carter moved to add Patty Zimmerman seeking a C.U.P. to have a cattery at her home and to add Lois Eaves for discussion on Dahlstorp Cemetery to the agenda, Chair Cupit 2nd. All in favor.

Chair Carter moved to take agenda appointments before the road report, Supervisor Cupit 2nd. All in favor.

C.U.P. to maintain hobby cattery. Patty Zimmerman (437th Street) is applying for a hobby cattery to operate out of her home. She is a breeder of domestic cats. The C.U.P. she is seeking will allow for up to 25 adult cats to be present in the home at one time, kittens will be in addition to the 25 adult cats. Litter is bio-degradable wood chips and is disposed in the regular garbage. There will be minimal neighborhood impact as most cats are shipped to their new owners. Mrs. Zimmerman provided the Board with a lay-out plan of her cattery showing the breeding cages, feeding stations and kitten areas. The cats are indoors and are not let outside and two sets of vaccinations are performed before the cats are sold. Supervisor Cupit moved approval with no conditions, Supervisor O'Keefe 2nd. Chair Carter abstains since he is a neighbor of Mrs. Zimmerman.

Dahlstorp Cemetery. Lois Eaves was present to discuss the Boards official start of maintaining the cemetery and the deed being transferred to the Township. The Board is prepared to take on the historical preservation of the cemetery. Selling of lots and development of the parcel will be discussed in the future. Supervisor Cupit prepared Resolution 2008-310 to officially start the process with Chisago County. The Township will maintain the cemetery for one year at which time Chisago County will transfer the title to the Township. Supervisor Cupit moved to accept Resolution 2008-310 Creating The Dahlstorp Cemetery Association, Supervisor O'Keefe 2nd. All in favor.
